

USES

USES

Pack of 24 boluses, each weighing 90g, in individual sachets.

TARGET SPECIES

Dairy cows

ADMINISTRATION

Dairy cows: Administer 1 bolus of Cap Calcium orally per animal at first signs of calving, and 1 bolus 12 hours after calving, using the Cap Calcium oesophageal applicator. The animal must be restrained during administration to avoid injuring it. The bolus dissolves over a 2 hour period.

COMPOSITION

Calcium phosphate, magnesium sulfate, magnesium oxide, waxy-leaf nightshade meal.
