PARTICULAR NUTRITIONAL PURPOSE

Reduction of the risk of acidosis.

PRESENTATION

Ready-to-use 500ml bottle (shake before use)

TARGET SPECIES

Dairy cows

ADMINISTRATION

- For dairy cows: 1 bottle of 500ml per animal in a single application
- Administer orally.
- Shake before use.
- Administer slowly to an upright animal.

OD-Flore contributes to the biochemical equilibrium in ruminants and stimulates ruminal flora. It is indicated when ruminal fermentation results in reduced pH, which in turn causes appetite loss and lower performance (growth, milk production, fattening). Ensure to distribute palatable fibrous fodder and divide/restrict the intake of rapidly fermentable starch in the diet. Especially for high yielding cows.

Do not administer to an animal that is lying on its side and/or that has difficulty swallowing.

Sodium bicarbonate, yeast products, propylene glycol, wheat feed.
